Motion to approve the minutes of the February 9, 2019 Special Meeting by Fuller, 2nd by Wantz carried 5 0.

- 3. Maryland Municipal League Summer conference Mayor and councilmembers should advise Clerk Kalman if they wish to attend
- 4. Carroll Vista Letter of Credit Reduction Attorney Gullo explained that this is now a release of the Letter of Credit. Motion to release by Wantz, 2nd by Fuller carried 5 0.
- 5. 5 G small cell update Staff will review in the upcoming week for an introduction of an ordinance in April.
- 6. Assistance for Federal Employees Mayor McCarron asked for unanimous consent to allow staff to work out payment arrangements for Federal Employees who have been furloughed, but with Frazier opposed, there was a motion by Vigliotti to approve assistance for Federal workers under the parameters defined by Acting City Manager Wieprecht and Mayor McCarron, 2nd by Foster. Frazier made a motion to table, but with no second, the motion died. Motion by Fuller to amend to limit the payment plan and suspension of late fees to only the current billing cycle, 2nd by Vigliotti carried 5 0. The vote on the original motion carried 5 0.
- 7. Retreat Date Mayor and councilmembers will decide at the February 20, 2019 budget meeting, if a retreat is desired.

Councilmember Wantz stated that, although he commented at the February 6, 2019
 Mayor and Council Workshop that he is opposed to the National Civil War Memorial project, he is not opposed to the establishment of a committee to discuss the project.
