I further state that I have complied with the requirements of the Taneytown Ethics Ordinance and have completed the required disclosure forms.

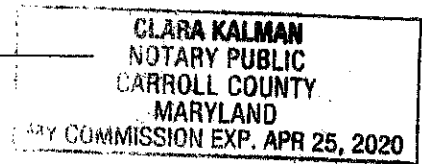
